In August 2006, I was working full time thoroughly enjoying everything that came with my job. However, my body had other plans. In January 2007, I had to leave my job and was soon placed on disability. This began years of struggle, lost friendships, doctors, medications, and years of depression. Here, I was a person who enjoyed the challenges of working and was no longer able to do what I loved.

My mother realized I needed a place where I could still make a difference, find new friends and be able to help on my own time. She was right! The group at the time, in 2007, was a ladies Red Hat organization in Colorado Springs. I felt needed and had time to work on things when I felt healthy. Eventually, the group changed along with the name, the direction, and the director. We are now Colorado Springs Ladies Events and as of March 2022, we are a non-profit 501(c)(3) organization recognized as a 502(a) public charity.

Since my health changed, I have realized that I have been very lucky. Many people who are unable to work or work with pain try to apply for disability and never receive it. Several of these people can end up needing assistance, possibly even homeless and where does that leave their children? This is one of the reasons I believe in the power of helping others. My goal of making Colorado Springs Ladies Events a non-profit was to teach the ladies there are so many needs in our community. I believe in the fact of helping our local community before we can help others around the country or world. We believe in "Empowering the Community!"

The organization has always donated to local charities; however, we can expand on our program. Our goal is to impact as many local charities as possible through fundraising and sponsorships. 


# Examples of non-taxable ACKNOWLEDGEMENTS

- Featuring the sponsor's name and logo in printed media, on a nonprofit's website, or on a banner at an event.
- 2. Posting a link that takes the viewer only to the sponsor's home page not to a page where a product or service is marketed or sold.
- 3. Displaying or distributing free samples of a sponsor's products at a nonprofit's event, as long as the nonprofit does not endorse the product/service.
  - Inviting corporate sponsors to special events, such as a dinner or reception, as long as the monetary value of the event is not more than 2% of the corporate sponsor's payment to the nonprofit.

# Examples of taxable "SUBSTANTIAL BENEFIT"

- Promising the for-profit that it will be the "exclusive" provider of products or services in return for sponsorship.
- Providing a link from the nonprofit's website to the page of a sponsor's website where products are sold, or listing the phone number where the products or services can be ordered.
- 3. Endorsing the sponsor, or inducing others to buy the sponsor's products or services.
- Giving more than token services or other privileges to the sponsor, such as tickets to an event or lavish receptions (!) if value to sponsor exceeds 2% of sponsor's payment to the nonprofit.
  - 5 Making sponsorship payments contingent upon how many people attend the nonprofit's event.
